

Dear Neighbor:

We are writing to update you on the construction of the Bay Park Conveyance Project. The Bay Park Conveyance Project is a partnership between the New York State Department of Environmental Conservation and the Nassau County Department of Public Works. Western Bays Constructors (WBC) is the design-builder for this innovative Project.

The Project will convey treated water from the South Shore Water Reclamation Facility at Bay Park (formerly known as the Bay Park Sewage Treatment Plant) to the existing Cedar Creek Water Pollution Control Plant's ocean outfall pipe, which discharges and diffuses treated water three miles offshore in the Atlantic Ocean. As part of this conveyance, the Project includes repurposing an existing aqueduct beneath Sunrise Highway, using a technique known as sliplining. Sliplining will occur within your community.

Pit S is located on the south side of Sunrise Highway, east of the Meadowbrook Parkway between Hewlett Avenue and Wynsum Avenue. Pit T is located on the south side of Sunrise Highway, just west of Newbridge Road. Pit U is located on the south side of Sunrise Highway, east of Newbridge Road, between Hanson Place and Argyle Place. Pit V is located on the south side of Sunrise Highway, just east of Bedford Avenue. As construction in your area continues, we want to give you as much information as possible. Here's what you should know:

In the coming days, crews will place a hydraulic jacking machine at the base of Pit T and begin

installing the new conveyance pipe into the existing aqueduct towards Pit U. Following this activity, the jacking machine will be moved to Pit S to push new conveyance pipe toward Pit T. The machine will then be relocated to Pit U and slipline toward Pit V. These sliplining operations are expected to last through August with additional activities to follow.

A comprehensive Maintenance and Protection of Traffic (MPT) plan will be deployed to protect the safety of drivers, pedestrians, and workers through the work zone and promote reliable traffic flow. Construction activities will take place from approximately 9 p.m. to 6 a.m., Monday through Friday. While work is underway, two eastbound lanes will be closed, and one eastbound lane will be open. Three lanes of traffic will be maintained during the day from 6 a.m. to 9 p.m. During operations at the respective Pit locations, the following road closures will occur.

### **Overnight Road Closures**

Pit S: Two eastbound lanes will be closed between approximately Hewlett Avenue and Wynsum Avenue.

Pit T: Two eastbound lanes will be closed just west of Newbridge Road.

Pit U: Two eastbound lanes will be closed between approximately Hanson Place and Argyle Place.

Pit V: Two eastbound lanes will be closed just east of Bedford Avenue.

Through a dedicated Community Outreach Program, WBC is committed to a robust engagement process and to maintaining an open line of communication throughout construction. We are also committed to minimizing disruption to neighborhoods affected by construction. WBC's Community Outreach Team will be available to answer questions and act as a project liaison throughout the duration of construction.
