

Dear Neighbor:

We are writing to update you on the construction of the Bay Park Conveyance Project. The Bay Park Conveyance Project is a partnership between the New York State Department of Environmental Conservation and the Nassau County Department of Public Works. Western Bays Constructors (WBC) is the design-builder for this innovative Project.

The Project will convey treated water from the South Shore Water Reclamation Facility at Bay Park (formerly known as the Bay Park Sewage Treatment Plant) to the existing Cedar Creek Water Pollution Control Plant's ocean outfall pipe, which discharges and diffuses treated water three miles offshore in the Atlantic Ocean.

Pit W is located on the south side of Sunrise Highway west of Lakeview Road. CC6 is located just off Lakeview Road south of Sunrise Highway in Wantagh. As construction in your area continues, we want to give you as much information as possible. Here's what you should know.

Crews are constructing an open trench from Pit W to CC6 to connect the Sunrise Highway pipeline to the Cedar Creek pipeline. This trench will extend through Lakeview Road. Construction of the trench involves continued installation of support of excavation (SOE), followed by soil excavation, pipe installation, grouting and roadway restoration. The WBC Community Outreach Team will continue to update you as the Project progresses.

On Sunrise Highway, one eastbound lane will remain closed between approximately Lakeview Road and Thomas Place and the left turn restriction to Lakeview Road will remain in effect. **Additionally, a road closure will be in effect on Lakeview Road, between Sunrise Highway just north of the Twinview Gardens Apartment Complex. This closure will begin late June and continue for approximately 2- 3 months.** To navigate this temporary road closure, a detour will be in effect directing traffic to use Bellmore Avenue to access Lakeview Road south of the closure. A comprehensive Maintenance and Protection of Traffic (MPT) plan will be in place to protect the safety of drivers and pedestrians.

Through a dedicated Community Outreach Program, WBC is committed to a robust engagement process and to maintaining an open line of communication throughout construction. We are also committed to minimizing disruption to neighborhoods near construction. WBC's Community Outreach Team will be available to answer questions and act as a project liaison throughout the duration of construction.
